Re: NFRC Competent Person Scheme (NFRC CPS)—Building Regulation Compliance Certificate

This Certificate is to certify that the roof refurbishment to your property is compliant with the appropriate Building Regulations that were in force at the time when the works were carried out. Your contractor has provided details of the work allowing us to issue a Building Regulations Compliance Certificate and pass the relevant details to your Local Authority Building Control Office.

Please ensure that you have received the correct documents and all details are correct.

Regulation

It is a legal requirement for certain roof repairs and replacements to be registered with your Local Authority Building Control or with a Government Accredited self-certification scheme, such as **NFRC CPS**.

1. NFRC CPS

Registration with NFRC CPS is not automatic. Contractors must satisfy stringent criteria in order to qualify for registration. We also conduct random inspections on works to ensure Contractors comply with the relevant Building Regulations. However, we cannot be held responsible for any liability in the event of a Contractor's works not being compliant with the appropriate regulations.

2. Guarantee

It is a requirement of NFRC CPS that the customer is provided with a written guarantee from the Contractor. Please ensure that you have received this guarantee and that details of the Contractor are the same as those shown on the certificate overleaf.

3. Insurance

a. Non-domestic customers must have been given the opportunity of an insurance policy to protect their guarantee in the event of the contractor ceasing to trade during their guarantee period. This could be by either:

1. An offer of insurance sent directly from an NFRC CPS recognised insurance provider; or

2. Your Contractor may have an arrangement where insurance is automatically given on all contracts, in which case you will receive the policy within six weeks completion of works.

b. Domestic customers automatically receive the benefit of a ten-year Insurance Backed Guarantee where the contract involves a contract value of less than £50,000 and the property being worked on has four floors or less.

Important: Please ensure that this certificate is kept in a safe place along with the contractor's guarantee and the insurance policy, if applicable. Any other documents relevant to your works should also be kept safe as these may be required if you sell your property.
